### **ORDINANCE NO. 1102**

AN ORDINANCE CHANGING THE ZONING DISTRICT CLASSIFICATION OF CERTAIN PROPERTY LOCATED IN THE CITY OF MAIZE, KANSAS, UNDER THE AUTHORITY GRANTED BY THE ZONING REGULATIONS OF THE CITY AS ORIGINALLY APPROVED BY ORDINANCE NO. 548.

## BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF MAIZE, KANSAS:

SECTION 1. After proper notice having been given and hearing held as provided by law and under authority and subject to the provisions of the Zoning Regulations of the City as originally approved by Ordinance No. 548, the Maize City Planning Commission recommends approval of Case No. PUD-01-025, an amendment to PUD-04, City of Maize, Kansas Ordinance 1009 and, that the zoning district classification of the property legally described herein be changed as follows:

Change of zoning district classification from the SF-5, Single-Family Residential District to PUD-01-025, Planned Unit Development

# **Legal Description:**

The South Half of the Northeast Quarter of Section 36, Township 26 South, Range 2 West of the Sixth Principal Meridian, Maize, Sedgwick County, Kansas, a.k.a Arvada Addition, Maize, Sedgwick County, Kansas.

### **General Location:**

1/3 mile south of West 37<sup>th</sup> Street North on the west side of North 119<sup>th</sup> Street West, Maize, Sedgwick County, Kansas.

SECTION 2. Upon the taking effect of this ordinance, the above zoning change shall be entered and shown on the Official Zoning Map(s) as previously adopted by reference and said Map(s) is (are) hereby reincorporated as a part of the Zoning Regulations as amended.

SECTION 3. This zone change shall be subject to the conditions as follows

Property shall be subject to all provisions of Arvada 2<sup>nd</sup> Addition, Planned Unit Development, PUD-01-025, Development Guidelines, General Provisions, Amendment No. 1 to PUD-04.

SECTION 4. This Ordinance shall take effect and be in force from and after its passage, approval and publication once in the official city newspaper.
